## AriSEIA Membership Dues

AriSEIA membership dues are based on gross company revenues. AriSEIA relies on the honor system to make sure companies are in the correct category.

We have numerous membership categories:

- **Level 1 - \$300** - Companies with gross annual revenue under US \$100,000.
- **Level 2 - \$495** - Companies with gross annual revenue greater than US\$100,000, but less than \$1 Million.
- **Level 3 - \$850** - Companies with gross annual revenue greater than US \$1Million, but less than 10 Million.
- **Level 4 - \$2,000** - Companies with gross annual revenue greater than US \$10 Million.
- **Utility - \$2,500**

### Non-Voting Memberships

- **Individual - \$100** - Individuals joining AriSEIA receive partial member benefits, e.g., no website listing and no voting privileges.

Membership dues are billed annually on the anniversary date of your joining. Members who join in December will receive credit for the full year that follows.
